

Once again, please immediately terminate my committee(s). I never opened a new presidential bank account therefore, I have not received any campaign contributions, nor have I had any expenditures.

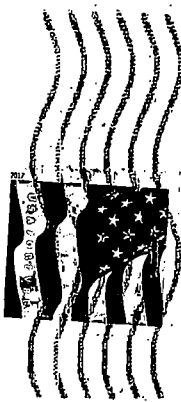

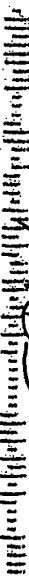
