Volunteers from Dallas County conduct activities such as voter identification, voter-registration, get-out the vote, and other generic campaign activities. Mileage Reimbursements are for travel for Committee Party Building business and not FEA activity. Transfers from the nonfederal account to pay the nonfederal portion of an allocable expense are made within a 70-day window: no more than10 days before or 60 days after the day the federal account (or allocation account) makes the payment.106.7(f)(2). The Committee reports expenses on Schedule H4, when required, for prior year period using the 36 and 64% ratio applicable for this Committee. Also reported are expenditures using the new ratio of 15 and 85% for this Committee new election cycle. Allocated Transfers reported on H3 include \$5,028.03 for prior year expenses.
