Dear Mr. Horton:

Our response pertains to two letters regarding the October Quarterly (8/3/00 to 9/30/00) referenced by April 3, 2001 date. The second letter was further referenced by a notation dated 10/23/00. The response is in the order of the letter received.

Schedule A appears to have excess contributions. We have reviewed your notations and found that the first notation of \$500 by B.L. Moore is in excess. Mr. Moore and his wife donated \$4,000 to the campaign in 1999, plus an additional \$500 in 2000. Our system normally warns of excessive contributions, but this instance it did not. We are in process of upgrading the system to avoid a repeat of this situation. We will refund the \$500 to Mr. Moore.

The second instance involved a contribution by husband and wife. Our internal record reflected only his name when reporting on the FEC report. We have separated the names on the database and such ambiguous reporting should have not reoccur. Mr. Ryan's apparent excess is attributed to his wife, Barbara.

Enclosed is an updated FEC Form 1, reflecting both Bancfirst and Bank of Cushing as depositories.

Enclosed is a Schedule A supporting the itemized receipts we reported to you on our 10/23 supplemental letter. They total \$31,988.56, which is our reported total on the 8/3/00-9/30/00 report for line 11(a)(i).

The column B figures reported are reconciled on the attached Excel worksheet. They do balance. The report did not itemize expenses under \$200, but did report total expenditures. Therefore, the totals as reported are correct.

We strive to meet both the spirit of the law as well as actual regulation and, therefore, welcome the review and the opportunity to respond. Please let us know if we can provide anything else.
