This response addresses the Reports Analysis Division’s (“RAD”) Request for Additional Information (“RFAI”) dated October 15, 2023, concerning Dave McCormick for US Senate’s (“Committee”) July Quarterly Report (04/28/2023 - 06/30/2023).

The Committee has remedied the contributions your letter listed that appear to exceed the contribution limits set by the Federal Election Campaign Act (the “Act”. Each of the donors will be refunded for their excessive contributions and the refunds will be reported on the Committee’s 2024 April Quarterly Report.

The Committee has remedied the contributions received and designated to the general election, with consideration the Candidate did not participate in the general election, as outlined below:
