Proposed Activities:

170 Freedom Milwaukee 2024 Host Committee, Inc., a Wisconsin nonprofit corporation (the "Corporation"), will promote commerce within Southeastern Wisconsin region in and around the City of Milwaukee, Wisconsin ("Milwaukee"), and project a favorable image of Milwaukee by participating in and preparing for the 2024 Republican National Convention. Specifically, the Corporation anticipates conducting each of the following activities:

- 1. To defray those expenses incurred for the purpose of promoting the suitability of Milwaukee as a convention site;
- 2. To defray those expenses incurred for welcoming the convention attendees to the city, such as expenses for information booths, receptions, and tours;
- 3. To defray those expenses incurred in facilitating commerce, such as providing the convention attendees with shopping and entertainment guides and distributing samples and promotional materials;
- 4. To defray the administrative expenses incurred by the Corporation, such as salaries, rent, travel, and liability insurance;
- 5. To provide the national committee use of an auditorium or convention center and to provide construction and convention related services for that location such as: construction of podiums; press tables; false floors; camera platforms; additional seating; lighting, electrical, air conditioning and loudspeaker systems; offices; office equipment; and decorations;
- 6. To defray the costs of various local transportation services, including the provision of buses and automobiles;
- 7. To defray the costs of law enforcement services necessary to assure an orderly convention;
- 8. To defray the cost of using convention bureau personnel to provide central housing and reservation services;
- 9. To provide hotel rooms at no charge or a reduced rate on the basis of the number of rooms actually booked for the convention;
- 10. To provide accommodations and hospitality for committees responsible for choosing the sites of the conventions; and
- 11. To provide other similar convention-related facilities and services.


