This letter is in response to your letter dated October 30, 2001 regarding filing of the Statement of Candidacy for Candidate ID Number H6MO03119. Your letter was sent to my Congressional Office at 1236 Longworth House Office Building, on or shortly after October 30, 2001. As of October 17, 2001, the mail service had stopped in the Capital Hill Buildings due to the letter opened in Senator Daschle's Office in the Hart Building that contained anthrax. In addition, anthrax was found in the Longworth and Ford House Office Buildings. The mail on Capitol Hill was not being delivered until this month, and then on a very limited basis. Upon receipt of your letter by my Congressional Office, the letter was forwarded to my Campaign Office where the situation was resolved.
