NOTE 1 - SHEADS AND ASSOCIATES

The Committee understands the obligation to this vendor has been reduced through the rental of the Committee's direct mailing list by the Committee's former direct mail consultant, Sheryl Losser. The Committee previously requested an accounting of all direct mail rental activities from the former direct mail consultant, Sheryl Losser, as well as from Sheads and Associates. Such accounting was not provided. Documentation has been provided which would indicate that the debt owed to this vendor has been reduced to \$4,632.09 resulting from rentals of the Committee's direct mail list by its former direct mail consultant. The Debt remains disputed, inasmuch as a final accounting has not occurred which may further reduce the obligation.

The Committee filed a formal complaint against Sheryl Losser. Subsequently, a default judgment was rendered in favor of the Committee. The litigation, however, has been reinstated and discovery has begun in this matter.

Until Sheryl Losser provides an accounting, as a result of the reinstatement of the case, the Committee remains unable to verify with specificity the actual amount by which the obligation to Sheads and Associates has been reduced as a direct result of the rental activities of Sheryl Losser. Thus, the Committee continues to dispute the amount of the obligation owed to Sheads and Associates.

NOTE 2 - KEZIOS PROPERTIES

The Committee's written lease agreement with Kezios Properties expired January 31, 1993. The Committee continued to occupy various locations within the property through May 1996 while attempting to negotiate the fair market rental value for those spaces. Those negotiations terminated and the Committee filed litigation seeking a declaration of its rights and obligations pertaining to its occupancy of those spaces. That litigation also seeks an accounting of payments made and the aggregate amount outstanding for those spaces. Kezios Properties filed a counterclaim containing several counts relating to the Committee's occupancy of various locations within the property. The counterclaim alleges purported breaches of various asserted leases and it seeks damages totaling \$174,195.08, plus interest and cost. Thereafter, Kezios Properties filed a Motion for Summary Judgment on Count I of its counterclaim relating to a portion of the property occupied by the Committee for which a formal written lease existed. The Motion for Summary Judgment was opposed by the Committee. The court granted Summary Judgment on Count I, resulting in the payment by the Committee of \$56,020.38 to Kezios Properties. The Committee continues to seek an accounting regarding those locations within the property for which, the Committee asserts, no formal written lease exists. Thus, the Committee vigorously opposes the remaining counts of the Counterclaim.
