Please note that for the independent expenditures that have been publicly disseminated, but not yet paid, the committee is using the obligation date, rather the payment date, on Schedule E, Line 24. In addition, the four independent expenditures for television and radio advertising production from 2/24/16 should not be considered new independent expenditures. The committee believed that the vendor that made the ad buys, Cardenas Strategies, had included the production costs in their invoice. It wasn't until the several weeks after the ads ran that the committee was invoiced separately for the production costs by Revolution Strategies. On the 2/16 24-hour notice, the committee disclosed that the New Florida Majority and Organize Now Inc. provided canvassing services for the Florida presidential primary. After reporting this activity, the committee learned that the New Florida Majority was not providing canvassing services and that Organize Now Inc. would be paid the original \$100,000 that was originally disclosed in addition to another \$100,000 that had previously been attributed to the New Florida Majority. The independent expenditure supporting Hillary Clinton in Nevada was disclosed on the 2/6/16 24-hour report with Field Strategies as the vendor. The committee was informed after disclosing this activity that the vendor was actually the Ardleigh Group and the amount of the expenditure increased from \$70,403.00 to \$90,593.02. On this amended report, the committee is disclosing a partial payment to this vendor of \$73,062.00 on Schedule E, Line 24, while the remaining \$17,531.02 is disclosed on Schedule E, Line 24 as a memo entry and has been added to Schedule D.
