Dear Sir or Madam:

On June 20, 2000, the Goldman Sachs Group, Inc. Political Action Committee ("GSPAC") submitted a letter with its June report indicating that we were unable to generate an electronic filing of that report due to internal computer problems and that the electronic filing of the June report would be effectuated once the problems were eliminated. The June report was filed manually on that day. At the time of the letter, we believed that GSPAC had initiated electronic filing with its May report, and was, therefore, obligated to file the June report electronically.

We are now advised by our technical support personnel that GSPAC did not initiate electronic filing with its May report (i.e., the May report was filed manually) because we have not yet been able to establish the necessary communication link with the Commission. Therefore, we write to inform the Commission that GSPAC does not intend to file the June report electronically, and will begin electronic filing once the communications link can be established.
