
Dear Ms. Daughtrey:

The Statement of Organization has been amended pursuant to your letter dated March 17, 2006. At your suggestion, we have changed our Type of Committee to a party committee, even though we have not yet raised the funds necessary to meet the definition of party committee, because we expect to meet that definition later this year. At some subsequent time, we expect to apply for an advisory opinion recognizing us as the Missouri state party committee for the Green Party of the United States.

The Green Party of the United States recognizes the Progressive Party of Missouri as its official Missouri affiliate. We use the name "Progressive Party" because the name "Green Party" is already in use in Missouri by a different party organization that is not affiliated with the Green Party of the United States.
