MCGUIRE FOR VIRGINIA IS SUBMITTING THIS FORM 99 TO NOTIFY THE FEDERAL ELECTION COMMISSION (FEC) THAT WE HAVE FILED AMENDED 30-DAY POST GENERAL (2024) AND YEAR-END 2024 REPORTS TO ACCURATELY REFLECT CHANGES REGARDING CERTAIN RECEIPTS AND DEBTS.

THE AMENDMENTS CORRECT THE REPORTING OF FUNDS ORIGINALLY CATEGORIZED AS RECOUNT AND ADJUST LEGAL DEBT ATTRIBUTIONS IN COMPLIANCE WITH FEC REGULATIONS AND REPORTING BEST PRACTICES.

THE FOLLOWING ADJUSTMENTS HAVE BEEN MADE:

(1) REMOVAL OF RECEIPTS PREVIOUSLY CATEGORIZED AS RECOUNT
A \$5,000 OTHER RECEIPT FROM THE EYE OF THE TIGER PAC HAS BEEN REMOVED.
A \$5,000 OTHER RECEIPT FROM SCALISE FOR CONGRESS HAS BEEN REMOVED.

(2) CORRECTION OF DEBT REPORTING ON SCHEDULE D
THE OUTSTANDING LEGAL DEBT TO HOLTZMAN VOGEL HAS BEEN REVISED TO ACCURATELY REFLECT THE PORTION ATTRIBUTABLE TO THE 2024 PRIMARY ELECTION FOR LEGAL SERVICES.
THIS ADJUSTMENT ENSURES THAT THE DEBT IS PROPERLY REPORTED WITHIN THE CORRECT ELECTION CYCLE.

(3) IMPACT ON YEAR-END 2024 REPORT CARRY FORWARDS
DUE TO THE REMOVAL OF THE ABOVE RECEIPTS AND ADJUSTMENTS TO SCHEDULE D, THE CARRY-FORWARD AMOUNTS IN THE YEAR-END 2024 REPORT HAVE BEEN UPDATED ACCORDINGLY.

(4) FUTURE REPORTING OF RECOUNT-RELATED TRANSACTIONS
THE REMOVED RECEIPTS AND DEBT DIFFERENCES WILL BE PROPERLY ACCOUNTED FOR IN A FUTURE REPORT FOR THE MCGUIRE RECOUNT COMMITTEE (C00900118), WHICH HAS BEEN SEPARATELY ESTABLISHED FOR RECOUNT-RELATED ACTIVITIES.
