Please find attached a copy of cancelled AFGE-PAC contribution check no. 1792 dated 03/14/00 for \$1,000. This check referenced the campaign period of Primary 2000 and was disbursed as thus; hence creating an error since the Primary date for the state of Maryland was 03/07/00. This check is currently in violation of the Federal Election Commission guidelines regarding contributions within a given election cycle because the contribution was disbursed after the state Primary.

As of 07/17/00 AFGE-PAC has contributed \$2,000 to your campaign for the election cycle of General 2000. As a solution to the issue above, the AFGE-PAC proposes a redesignation of the 03/14/00 \$1,000 check to the General 2000 election cycle in lieu of a refund. If this proposal meets with your approval please sign below and return to the AFGE-PAC office at 80 F Street, NW, Washington, DC 20001.
