Dear Ms. Mongeon:

This statement is in response to the Commission's letter to the Committee dated June 10, 2018, regarding three items related to the above-referenced report ("the Original Report").

First, as disclosed on the Original Report, the Committee confirmed that the contribution from the referenced contributor was made with permissible funds. See <http://docquery.fec.gov/cgi-bin/fecimg/?201805169112056953>.

Second, in regard to the contributions received from two individuals with mailing addresses outside of the United States disclosed on the Original Report and listed on the attachment to the Commission's letter, all of the funds were contributed by credit card and have been charged back to the contributors' credit cards. Those chargebacks will appear on the appropriate report.

Third, the Commission's letter requests clarification on contributions from 95 contributors disclosed on the Original Report that appear to exceed federal contribution limits. As described below, all of those contributions were properly and timely redesignated, reattributed, or refunded/charged back, as will be reflected on either the Amended 2018 April Quarterly Report being filed concurrently with this response ("the Amended Report") or the Committee's upcoming 2018 July Quarterly Report:

- Fifteen of the listed contributors' contributions were redesignated to another election.
- Five of the listed contributors' contributions were either refunded or charged back to the contributor's credit card.
- Five of the listed contributors' contributions were already refunded but had the incorrect election designation; the correct election designation will be reflected on the Amended Report.
- Sixty-seven of the listed contributors' contributions were made by contributors who had contributed to the Committee but subsequently made additional contributions to either Trump Victory (C00618389) or Trump Make America Great Again Committee (C00618371) - joint fundraising committees ("JFCs") in which the Committee participates - which transferred the contributions to the Committee. Any excessive contributions that resulted from funds received by the Committee through a JFC have been returned to the JFC for reallocation among its participants in accordance with the allocation formula set forth in the governing joint fundraising agreement. The reallocations will be disclosed by the relevant JFC on the appropriate report.
- Finally, three of the listed contributions were in part (i) redesignated to another election and (ii) either refunded or returned to the JFC that transferred the contributions to the Committee and reallocated by that JFC among its participants in accordance with the allocation formula set forth in the governing joint fundraising agreement.
