Dear Federal Election Commission,

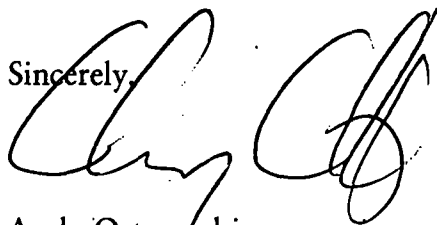

"Each individual who is a candidate for federal office must file FEC FORM 2 (when) ... (t)he individual has received contributions aggregating in excess of \$5,000 or made expenditures aggregating in excess of \$5,000."

My campaign has only now reached the \$5,000 threshold of campaign donations required to file a Form 2 Statement of Candidacy.

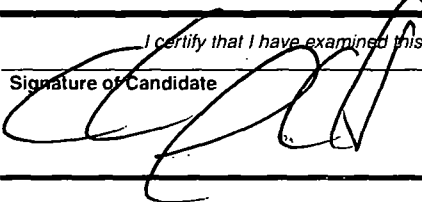

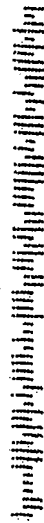
