
Dear Ms. McBride:

This letter responds to your request for additional information regarding the Statement of Organization of Pennsylvania Victory Fund (copy enclosed).

1. Enclosed you will find an amended Statement of Organization for Pennsylvania Victory Fund. I have clarified that the Fund is a joint fundraising committee by checking the box 5(f) instead of 5(b) as it appeared on the original statement. Because a joint fundraising committee is an authorized committee, I understood that 5(b) was the appropriate box to designate.

2. Victory '94 Committee is a joint fundraising committee with the Citizens for Senator Wofford and the Democratic Senatorial Campaign Committee as participants. Pennsylvania Victory Fund is a joint fundraising committee with Citizens for Senator Wofford, Friends of Singel and the Pennsylvania Democratic Party as participants. Thus, Citizens for Wofford is a fundraising participant in both Victory '94 Committee and Pennsylvania Victory Fund. I serve as treasurer of both joint fundraising committees as well as Senator Wofford's reelection campaign treasurer.

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Your Statement of Organization indicates in Line 5(b) that you are an authorized committee for Harris L. Wofford. However, in line 6 you indicate Citizens for Senator Wofford, Friends of Singel and the Pennsylvania Democratic Party are joint fundraiser participants. Please clarify this discrepancy.

-Your Statement of Organization states that your committee is a joint fundraising participant with Citizens for Senator Wofford Committee. FEC records indicate however, that Citizens for Senator Wofford is also a joint fundraising participant with the Victory '94 Committee. Please explain your affiliation, if any, with the Victory '94 Committee which shares an address and treasurer with your committee.

A written response or an amendment to your original report(s), correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
