Dear Ms. Mongeon:

This statement is in response to the Commission's letter dated October 12, 2016 regarding five items.

First, with respect to the non-federal committees listed, our Committee has safeguards in place to ensure these committees used permissible funds for their contributions. After research, the Committee has confirmed that these non-federal committees used federally permissible funds.

Second, regarding contributions from an LLC (limited liability company), our Committee has safeguards in place to ensure that all contributions are made by eligible contributors only. With respect to the two contributions referenced in your letter, we have confirmed that those contributions were made with federally permissible funds. Partnership attributions have been included on the Amended report.

Third, the excess amount of the contribution from America Comes First PAC has been reallocated through the joint fundraising committee, Trump Victory (C00618389), and will be reflected on the Committee's Post-General Report.

Fourth, you requested clarification on contributions that appear to exceed federal limits. 29 of the contributions have been refunded and will be reflected on the appropriate report. The remaining 37 contributions came from contributors who had already contributed to the Committee, and additional funds were contributed via a joint fundraising committee, either Trump Victory (C00618389) or Trump Make America Great Again (C00618371). Any excessive amounts have been returned to that committee for proper reallocation, and will be disclosed on the appropriate report.

Fifth, the contribution refund for NIA National Insurance was reported with the incorrect election designation. This will be corrected on an amended report. The in-kind contribution from Preston Wells Griffith was inadvertently unitemized on Schedule A and will be itemized on an amended report. Cash on hand is not affected. The contribution refund from Randy Treibel constitutes an aggregate refund of eight different contributions during July and August. The one aggregate refund was issued for administrative convenience instead of eight separate refunds. The chargeback from Shen Tan was erroneously included along with accompanying unitemized receipts due to a clerical error. These will be removed on an amended report. Cash on hand is not affected.
