The digital advertising expenditure supporting Hillary Clinton and opposing Donald Trump disclosed on page 73 is a nationally targeted ad. The \$30 expense that supports Hillary Clinton should be allocated among the remaining 20 states that have yet to hold Democratic primaries by the date of dissemination for a total of \$1.50 per state and the \$10 expense that opposes Donald Trump should be allocated amount the 16 states that have yet to hold Republican primaries by the date of dissemination for a cost of \$.63/state. It should also be noted that for all independent expenditures that are disclosed as memo entries on Schedule E, Line 24, the committee is using the obligation date and not the payment date to report these transactions as they have not been paid. These independent expenditures have also been disclosed as debt on Schedule D.
