Dear Mr. Furman,

This statement is in response to the Commission's letter to the Committee dated August 19, 2020, regarding certain contributions disclosed on the above-referenced report ('the Original Report').

The Commission's letter requests clarification on contributions from four committees that appear to exceed contribution limits. The election designations for the contributions from three of the committees, Defending American Values Everywhere PAC (Dave PAC), Warrior Diplomat PAC and Winning For America, have been corrected on the Amended July Monthly Report ('Amended Report') being filed concurrently with this response. From a review of FEC filings, the Committee understands that Leadership For America Today Tomorrow And Always PAC has qualified as a multi-candidate committee and therefore its contribution does not require any further action. If this not correct, please let us know so we can take corrective action.

The Commission's letter also requests clarification on contributions from 1,050 contributors disclosed on the Original Report that appear to exceed federal contribution limits. All of the listed contributions were properly and timely redesignated, reattributed, refunded/charged back, or returned to a joint fundraising committee ('JFC') in which the Committee participates for proper reallocation, as is or will be reflected on either (as appropriate) the Amended Report being filed contemporaneously with this submission or on a subsequent Committee Report:

- 862 of the listed contributors' contributions were redesignated to another election.
- 1 of the listed contributor's contributions were either refunded or charged back to the contributor's credit card.
- 39 of the listed contributors' contributions were made by contributors who had contributed to the Committee but subsequently made additional contributions to either Trump Victory (C00618389) or Trump Make America Great Again Committee (C00618371) - JFCs in which the Committee participates - which distributed the contributions to the Committee. Any funds received through a JFC distribution that resulted in an excessive contribution have been returned to the JFC for reallocation among participants in accordance with the allocation formula set forth in the governing joint fundraising agreement. The reallocations will be disclosed by the relevant JFC on the appropriate report.
- 147 of the listed contributors' contributions were in part (i) redesignated to another election and (ii) either (a) refunded or (b) returned to the JFC that transferred the contributions to the Committee to be reallocated by that JFC among its participants in accordance with the allocation formula set forth in the governing joint fundraising agreement. The refunds or reallocations will be disclosed by the relevant committee on the appropriate report.
- 1 contribution of \$10,000 was mistakenly reported on the Original Report as having been made by an individual ('Roy B. Fund'). However, that contribution was, in fact, made by Rely On Your Beliefs Fund (C00344648), and has been designated \$5,000 toward the primary election and \$5,000 toward the general election. This was disclosed on a previously filed amended report and will be reflected on the Amended Report being filed contemporaneously with this submission.
