This responds to your September 19, 2008 letter requesting additional information concerning the above-referenced report. Specifically, you requested additional information concerning two contributions from The Scooter Store Inc. Political Action Committee ("PAC") to Texans for Senator John Cornyn, Inc. ("Campaign").

We have reviewed our records in response to your letter and determined that the \$2,500 contribution from the PAC to the Campaign that was made on April 4, 2007 was made for the primary election, not the general election. We have filed an amended report (attached) disclosing the contribution as a primary election contribution to correct this inadvertent mistake. Therefore, the PAC did not make an excessive contribution to the Campaign.
