Dear Mr. Furman,

This statement is in response to the Commission's letter to the Committee dated March 17, 2021, requesting additional information on four items related to the above-referenced report ("the Original Report").

First, concurrently with this response the Committee is filing an amended version of the 2020 30 Day Post-General Report ("the Amended Report") that corrects the Column B-P totals on the Detailed Summary Page(s). Those totals now correctly equal the sum of the Column B-P figures on the Committee's October Monthly Report and the Column A-P figures on the Amended Report.

Second, the Commission's letter requests clarification regarding certain contributions disclosed on the above-referenced report that appeared to exceed federal contribution limits.

- The Commission's letter identifies apparent excessive contributions from National Rifle Association of America Political Victory Fund and Bill Flores for Congress, which the Committee received through a distribution from the Trump Victory (C00618371) joint fundraising committee ("JFC"). The excessive portion of those contributions was returned to Trump Victory for reallocation among its participants in accordance with the allocation formula set forth in the governing joint fundraising agreement.

- The Commission's letter identifies apparent excessive contributions received from People4America Federal Committee. The excessive portion of this committee's contributions were timely refunded, and the refund will be reported on a subsequent Committee report filed with the Commission.

- The Commission's letter requests clarification on contributions from 804 contributors disclosed on the Original Report that appear to exceed federal contribution limits. All of the listed contributions were properly and timely redesignated, reattributed, refunded/charged back, or returned to a joint fundraising committee in which the Committee participates for proper reallocation, as is or will be reflected on either (as appropriate) the Amended Report being filed contemporaneously with this submission or on a subsequent Committee report filed with the Commission:

o 111 of the listed contributors' contributions were redesignated to the Committee's recount fund.

o 344 of the listed contributors' contributions were either refunded or charged back to the contributor's credit card.

o 147 of the listed contributors' contributions were made by contributors who had contributed to the Committee but subsequently made additional contributions to either the Trump Victory or Trump Make America Great Again Committee (C00618371) JFCs, which distributed the contributions to the Committee. Any funds received through a JFC distribution that resulted in an excessive contribution have been returned to the JFC for reallocation among participants in accordance with the allocation formula set forth in the governing joint fundraising agreement. The reallocations will be

disclosed by the relevant JFC on the appropriate report.

o 202 of the listed contributors' contributions were in part (i) redesignated to the Committee's recount fund and (ii) either (a) refunded or (b) returned to the JFC that transferred the contributions to the Committee to be reallocated by that JFC among its participants in accordance with the allocation formula set forth in the governing joint fundraising agreement. The refunds or reallocations will be disclosed by the relevant committee on the appropriate report.

Third, the Commission's letter requests clarification regarding certain apparent "last minute" contributions reported on the Original Report but which appear not to have been disclosed on a 48-hour notice:

- 65 of the listed contributions were immediately refunded by the Committee via credit card chargeback the same day they had been attempted to be made. The Committee believes it is questionable whether the Committee ever "received" these amounts and should have reported them on the Original Report. Yet, to ensure the public record is clear, the Committee has left these amounts presented on the Amended Report.

- 168 of the listed contributions were disclosed on a 48-hour notice but were reported with the wrong receipt date or JFC transfer date on the Original Report. The relevant receipt dates or JFC transfer dates for these contributions have been corrected on the Amended Report.

- 17 of the listed contributions were disclosed on a 48-hour notice but with slight discrepancies in the contributor names presented on the Original Report. The presentation of these names has been corrected on either the Amended Report

or an amended 48-hour notice, as appropriate.

- 37 of the listed contributions did not need to be disclosed on a 48-hour notice because the contributions were received by the Committee after the 48-hour notice cutoff date but reported with the wrong receipt date on the Original Report (such as mistakenly reporting the date of the check as the receipt date). The relevant receipt dates for these contributions have been corrected on the Amended Report.

- The other listed contributions were not disclosed on 48-hour notices because of miscommunication at the Committee. The Committee has reviewed and improved its processes to prevent the re-occurrence of similar reporting issues in the future.

Fourth, the Commission's letter requests clarification regarding certain "last minute" contributions that were disclosed on 48-hour notices but which did not appear to be reported on the Original Report:

- 437 of the listed contributions were disclosed on the Original Report but with slight discrepancies in the contributor names presented on the 48-hour notice. The presentation of these names has been clarified on either the Amended Report or an amended 48-hour notice, as appropriate.

- 331 of the listed contributions were disclosed on the Original Report but with the wrong receipt date compared to the 48-hour notice. The receipt dates for these contributions have been corrected on the Amended Report.

- 19 of the listed contributions were reported correctly on the Original Report but had been presented with an incorrectly transcribed amount on the 48-hour notice. These amounts have been corrected on amended 48-hour notices.

- 13 of the listed contributions did not require reporting on the Original Report because they reflect amounts that had been previously reported on timely 48-hour notices and were inadvertently reported a second time on another 48-hour notice. These duplicative contributions have been removed from amended 48-hour notices.

- 6 of the listed contributions were disclosed on the Original Report but were incorrectly recorded with the spouse's

name on either the Original Report or the 48-hour notice. The presentation of these names has been clarified on either the Amended Report or an amended 48-hour notice, as appropriate.

- The other listed contributions were not itemized on the Original Report because of a software aggregation error -- but all of the funds were accounted for and reported on Line 17 of the Original Report. The required itemizations are included on the Amended Report, yet have no impact on the Committee's total receipts or cash-on-hand figure reported on the Original Report.
