
MEMORANDUM

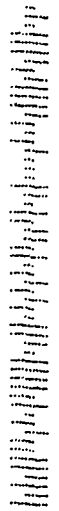
