I am writing as Treasurer of Effective America PAC to request termination of the committee's registration with the Federal Election Commission.

I sincerely apologize for not filing the termination paperwork earlier. During this time, my father was diagnosed with cancer, and I lost focus on the committee's filing status. I understand that this does not remove my responsibility as Treasurer, but I wanted to honestly explain why the filing was delayed.

The committee has not conducted any political activity, has not made any independent expenditures, and has not raised or spent funds for political purposes. The committee's bank account has now been closed. At the time of closing, the account showed a small negative balance of \$4 related to the bank account, and has been resolved with the bank.

Consistent with the enclosed Termination Report, the committee now has \$0.00 cash on hand, no remaining assets, and no outstanding debts or obligations.

I request that the Commission accept the enclosed Termination Report and terminate the committee's filing obligations.
