On September 6, 1996 a check was issued payable to the National Democratic Party and was delivered to the National Headquarters in Chicago. The Check was # 2481 in the amount of \$2500.

We later discovered the check was written on the Florida Association of Mortgage Brokers general account rather than on the FAMB Federal PAC account.

I called the National headquarters several times to request that they return that check to me and I would issue a new check from the Federal PAC account. (This was my instructions from the Federal Elections Commission when I asked them how to correct it).

By March 13, 1997 when I had heard nothing from the Democratic Headquarters and the check had already gone through our bank, I made a decision to transfer the \$2500 from the FAMB Federal PAC account and replace the monies in the FAMB general account to get both accounts in the correct order. If this was an incorrect move, please advise how I should better handle this matter.
