The review of that report identified 1) the calculations for Line 8 appear to be incorrect, 2) the calculations for Line 6(a) and 6(b) are not the same and 3) there was a memo entry in Line 21(b) with no corresponding itemized transaction. The Committee has corrected lines 8 and 6(a) in this amendment. The memo item disclosed in the original report was an erroneous memo item and has been removed from the report in this amendment. Also please note that the bank service charges have been classified as operating expenses. Thank you.
