Dear FEC Staff, -

Per my phone and email communication with your Branch Chief Nataliya Ioffe, we are filing this statement as a Form 99 to address the discrepancy the Addivinola Committee has in its cash-on-hand amount on its reports and the actual amount in the bank account.

Since the 2012 July through the 2014 July Quarterly reports, there are incorrectly reported candidate's out-of-pocket expenditures on behalf of the committee and the committee's reimbursements to the candidate. During the course of his campaigns, the candidate made out-of-pocket expenditures on behalf of the committee and sought eventual reimbursement. These amounts were disclosed incorrectly by the Treasurer as candidate loans (Schedule C) instead of Debts (Schedule D) – the method used when a committee deposits money from the candidate. In our case, no money from the candidate was deposited in the committee's account, and this lead to cash-on-hand discrepancies in the Line 13(a) entries.

Due to these errors, the receipts were inflated by the amount that the candidate spent out of pocket during each reporting period. The total of such increases appears to be \$108,388.41 (itemized summary attached herein).

Therefore, the committee hereby filing this letter as a Miscellaneous Document Form 99 to attest to these errors. The committee's current cash-on-hand bank balance is \$55.10.

The committee is also hereby requesting to terminate its active status and be dissolved.
