I live in Oakton in the VA-11 district on Bushman Drive in a condominium community as a single divorced man since 2010-'11, divorced in Rockville, Maryland, with two adult children living their own lives. I will serve voluntarily no more than three (3) 2-year terms or a total of 6 years or 1 full senate term, and let others serve after me, voluntarily limiting my own tenure in Congress with 6 specific goals to achieve decided in each of the 6 years in concert with my Congressional District VA -11 for my constituents to hold me accountable for my performance as their representative. 4. I will always vote my conscience. And to run, my individual personal campaign contributions shall not voluntarily exceed more than \$12,000 prorated for the remainder of the calendar year 2025. I will not take contributions from corporations and lobbyists. 5.
