Pursuant our conversation today, this letter is submitted to correct a mistake made in the November 17, 2009 filing of the Statement of Candidacy and Statement of Organization on behalf of campaign committee, 'Kevin Powell for Congress 2010'.

At the time of the November filing, I was instructed by another FEC representative to file the forms as amendments to establish the new committee.

However, as a result of our conversation today I became aware that the paperwork I submitted on November 17, 2009, did not result in a new committee for the 2010 election as intended. Furthermore, I now understand that the November filing erroneously resulted in me being identified as the Treasurer and Custodian of Records of the 2008 committee, Kevin Powell for Congress.

As I indicated, I do not hold, nor have I ever held the position of Treasurer or Custodian of record for the 2008 campaign committee, 'Kevin Powell for Congress. Furthermore, I do not have access to, or knowledge of, the records for the 2008 committee.

With that, I have included a Statement of Candidacy and Statement of Organization for the 'Kevin Powell for Congress 2010' campaign committee as a new, not amended, filing to establish this new committee. The filing does reflect that I do hold the position of Treasurer and Custodian of Record.
