Dear Ms. Seay:

I just received your letter June 8, 2007 regarding an omission 5(c) of the Form 1 I filed. The omission was an accidental error on my part and I am enclosing a new Form 1 with the candidate's name "Barack Obama" included. I apologize for my error and causing you paperwork that I could have prevented. I hope the inclusion of our web site address on Form 1 was of some clarification in this interim.

I have also changed line 8 "Title or Position" from "Founder" to "Treasurer". While I hold both positions it occurred to me that the FEC may prefer to have me listed as having both titles since that title is used in my communications with the FEC.

In case you need background information:

Our Group promotes a Gore-Obama ticket (Gore for President, Obama for Vice president) for the 2008 general election.

This presented an unusual situation in that


- Since Al Gore has not announced his candidacy for President, there was a "Draft Gore" aspect to our organization.
- Since our organization promotes Barack Obama as Vice President, not President, there is a "Draft Obama for VP" aspect.
- Since Barack Obama is a candidate for President, there may be an "announced candidate" aspect also that may be considered.

Prior to completing the Form 1 I contacted the FEC to seek clarification as to the proper box to check on line 5. I was told that although our group has a multi-candidate aspect, 5(f) was not appropriate because Al Gore has not announced his candidacy. In addition, since Barack Obama had announced his candidacy for the presidency, even though we are interested in him for the VP slot, I was instructed to check the 5(c) box.

At the time I was just about to leave town for several days and wanted to get my Form 1 in. It is entirely my error that in my rush I did not fill out the candidate's name as "Barack Obama". It is my understanding that if Al Gore announces his candidacy for the presidency I am required to automatically submit an updated form 1.
