This letter is in response to the Federal Election Commission's compliance review for the July and October quarterly reports. Attached, please find amended reports responding to questions raised concerning certain information contained in the reports. Additionally, please find correspondence and copies of refunded checks to corporate contributors.

Our 'best effort' procedures to get the required information on contributors includes efforts to solicit the information at the time of the contribution by having written materials that explain the requirements and verbally reiterating them at most events. If we receive contributions and the information is not provided, we complete the following process:


- 1) We make a clear and conspicuous request for the information from the contributor and inform the contributor of the requirements of federal law for the reporting of such information. (11 CFR 104.7 (b)(1))
- 2) If not provided, we follow-up with written correspondence clearly asking for the missing information, without soliciting a contribution informing the contributor of the requirements of federal law for the reporting of such information; we include a return envelope.
- 3) We seek to amend the Schedule A listing all the contributions for which additional information was received and file on or before the next regularly scheduled FEC reporting date.

In addition, if that fails we do phone book and directory assistance searches to identify contact information to reach the contributor. We will continue to persist in our efforts to get the required information on contributors.

We will file an amended Schedule A with our next regularly scheduled report, listing all the contributions for which additional information was received.
