
Dear Sir or Madam:

Enclosed for filing is the Mayor, Day, Caldwell & Keeton Political Action Committee's January 31 Year End Report which covers the period of November 24, 1998 through December 31, 1998.

I spoke with Mr. Edward Ryan, Reports Analyst concerning the filing of this report. Based on this discussion, my understanding is that the loans which were previously reported on Line 13 were actually contributions made by the 44 partners of Mayor, Day, Caldwell & Keeton, L.L.P. Therefore, in this report, I have backed the loans out of Line 13 and reported them as contributions on Line 11 a. i. and Line 11 a. ii. The amount of the contribution is based on the percentage owned by each partner in the firm. For those partners who are over the \$200 threshold, the amount attributed to those partners is itemized on Schedule A. The remaining contributions are unitemized on Line 11 a. ii. because the amount apportioned to each of the remaining partners is below the \$200 threshold.
