All taxes and fringe benefits are treated accurately for this reporting period. All activities referred to in this FEC request were for employees who spent less than 25% of their time on FEA. The Schedule H4 expenditure for compliance and treasury services is not for an employee. The provider of these services acts as a consultant. Expenses paid for voter file maintenance are monthly recurring and fixed charges for the maintenance of the voter file. Line 17 receipts on this report are reported correctly. These receipts are for filing fees collected from Federal candidates. In each entry reported on line 17 the person, or candidate committee, is remitting funds for filing. Some candidates used financial instruments that were drawn on personal funds for filing fees. The total of Line 17 for this reporting period is in turn paid out entirely as reported on Schedule B line 29 (\$33,040.00) to the SC Election Commission.
