
On behalf of the above referenced candidate for the US Senate, I have previously filed by certified mail FEC Form 2 and FEC Form 1 with your office. 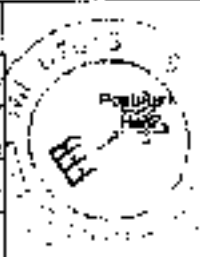
