In October 2024, KPMG PAC discovered that a \$10,000 check written to a federal committee was intercepted, altered and cashed by an unknown party. Upon becoming aware of the fraudulent activity, KPMG PAC notified PNC Bank of the issue and disputed the transaction. At the same time, a police report was submitted to the District of Columbus police department. KPMG PAC was notified on 7/16/2025 that PNC Bank was unable to recover the funds from the unknown party. The fraudulent transaction is disclosed on Line 29 of the M8 FEC filing covering July 2025.
