I was on a temporary relocation assignment starting in 2014 (for about 18 months) and my backdoor was attacked, while i was helping the United States with a REIT venture. Some REIT partners must have wanted me to stay overseas longer than I agreed to, and may know why I'm having issues with the backdoor. The backdoor is not allowing me to function or communicate effectively. My camcorder and voice recorder were disabled after capturing recordings of misbehavior. I've been unable to open a case with IC3 or the FBI. If possible, please open a case.
