Dear Mr. Gibson:

This letter is in response to your letter of April 24, 2003 regarding the Saxby Chambliss Victory Committee Statement of Organization. You have questioned the use of a candidate name in the name of a political committee.

In my letter of April 15, 2003 I responded to correspondence from Ms. Kristin Davis, stating that the Saxby Chambliss Victory Committee was an authorized committee of Chambliss for Senate, and therefore, use of the candidate name in the committee was appropriate.

In response, you have sent a letter requesting a name change citing that:

...a political committee which supports or has supported more than one candidate may not be designated as an authorized committee of a federal candidate. §102.13(c)(1)

I wish to clarify that the Saxby Chambliss Victory Committee was an authorized committee of Chambliss for Senate and *never* supported more than one candidate. Therefore, according to the rules, use of the candidate name is appropriate.

Thank you for your follow up letter and I hope that this will resolve this question to your satisfaction. Please feel free to contact me directly if you have questions or require additional information.
