We write in response to the Commission's letter dated May 9, 2012, regarding the Committee's Year End 2011 Report.

The Committee has done its best efforts to obtain the employer and occupation for all contributors who have an aggregate contribution of \$200 or more. The Committee includes a best efforts notification on all solicitation materials, and if an employer and occupation is not supplied when a contribution is made, the Committee follows up to ask solely for the employer and occupation with first a phone call, then an email, and then a letter within 30 days of the initial contribution. The Committee has received new information for the following individuals.

On the second item, the Committee does its best efforts to report the contribution under the individual with whom signed the written instrument when the contribution is in the form of a written instrument. When the contribution is made through a credit card contribution where the contributor filled in the information themselves, the Committee contacts the contributors first via a phone call, then an email, and then a letter to obtain information on who to attribute the contribution to. The Committee has contacted Ray and Ruby Silva to determine who the attribute the contribution to, and they have asked that the contribution be attributed to Ray Silva. This will be shown on the July Quarterly Report.
