Our office represents U.S. Senate candidate and Alaska Lieutenant Governor Mead Treadwell's principal campaign committee, Treadwell Alaska, Inc. (FEC C00546135).

From November 30, 2012 through June 18, 2013, Treadwell Alaska operated as an exploratory committee. As required by law, the exploratory committee kept financial records of all funds raised and spent for testing-the-waters activities, and only raised funds as allowed under the Federal Elections Campaign Act, but was under no obligation to report during this phase. (11 CFR 101.3; 100.72(a)).

On June 18, 2013 Lieutenant Governor Treadwell declared his candidacy for U.S. Senate, and the following day Treadwell Alaska filed its statement of organization as his principal campaign committee. All of Treadwell Alaska's contributions and expenditures became reportable on the first report deadline after its filing as a principal campaign committee. (11 CFR 100.131(a)).

Treadwell Alaska's first report deadline is the July 15, 2013 deadline to report 2<sup>nd</sup> Quarter activities. Accordingly, filed herewith are reports accounting for all of Treadwell Alaska's activities dating from its formation as an exploratory committee, and through its conversion to a principal campaign committee, up to June 30, 2013. These reports include its Year-End Report, 1st Quarter Report and 2nd Quarter Report.


