This amendment is filed in response to the FEC's request for additional information dated July 16, 2014. No change has been made to the reporting of the joint fundraising memo that identified an in-kind memo contribution (Reid Hoffman); per discussion with the FEC analyst, the memo reporting that was originally provided is deemed sufficient. The amended report does include a correction to the reference to the joint fundraising transfer from the Association of State Democratic Chairs/Dollars for Democrats. The transaction is now more clearly identified as being from Dollars for Democrats and the related committee identification number has been corrected; this reference is consistent with the committee's Statement of Organization. In addition, the report is amended to change the attribution of a joint fundraising memo contribution; the memo contribution that was originally attributed to Michael Leffler (\$10,000) is now attributed to Andrea Grant.
