I want to call your attention to a particular problem that I have had with the Aristotle Publishing Company software that this campaign has used for reporting purposes. The program correctly marked the box in the Schedule A forms that says "Primary" during the Primary Election Cycle. When that was over, the program continued marking the Primary box during the General Election Cycle, as well as the box labeled "General." So all reports that have been submitted during the General Election Cycle show both boxes marked.

In addition, I noticed while preparing this latest report that the program was not carrying forward past contributions for a correct aggregate number. Since Mr. Cunneen lost the election, we have not renewed our technical support agreement with Aristotle. Therefore, I have not been able to use Aristotle's technical support to correct this problem. In order to show the correct aggregate amounts, I have written them in by hand after referring to each entry in the data base.
