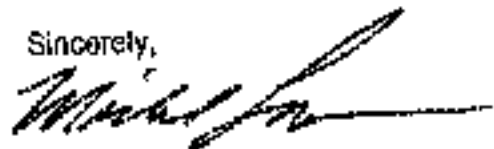
Dear Ms Boody:
