The Tennessee Leader Victory Fund is a joint fundraising committee registered with the Federal Election Commission. The committee exists to raise funds for its participants. The committee is administered by volunteers and pays Wachovia for banking services. The only expenses incurred by this committee are for fundraising. The committee will have fundraising events periodically and will be paying the expenses that arise from those events. A detailed review of our reports will show that our expenses are disclosed adequately and accurately. There were no expenditures made on behalf of specifically identified federal candidates on Schedule B supporting Line 21(b) of the Detailed Summary Page. These payments are on the appropriate line as they do not require Schedules E or F. The Tennessee Leader Victory Fund is a joint fundraising committee that exists to raise money for its participants. A review of our FEC Form 1 will show that the following committees are listed as participants: Tennessee Republican Senate Nominee General Election Committee, Volunteer PAC and the National Republican Senatorial Committee.
