Our Amended February, March, and April Monthly reports do not disclose any payments for salary or wages on Schedule B supporting Line 30(b) of the Detailed Summary Page because no individual employee of the committee spent more than 25 percent of their time during any one of those months on activities in connection with a federal election. The payment to Malchow, Schlickman, Hoppey & Cooper has been corrected to reflect that it was an administrative expense and the aggregate YTD total has been updated. The transactions that contain the words 'Balance due' are referencing the fact that the payments were the final payments for work completed by a vendor. These payments are all accompanied by other words to describe what the disbursements were for, in addition to the words 'balance due' and therefore, have not been changed.
