All of the services to ensure compliance with the Federal Election Campaign Act, that the National Football League donated to the PAC for the period of April 1, 2018 through April 30, 2018, took place from April 1, 2018 through April 20, 2018.

The National Football League ('NFL') provided 1.5 hours of professional staff time (valued at approximately \$243.96) in this reporting period with respect to PAC activities such as fundraising and decision making about contributions. The National Football League also provided 1.5 hours of administrative staff time (valued at approximately \$33.00) in this reporting period with respect to PAC activities such as fundraising and decision making about contributions. All of the services, with respect to PAC activities such as fundraising and decision making about contributions, that the NFL donated to the PAC for the period of April 1, 2018 through April 30, 2018 took place on April 4, 2018 through April 25, 2018.

On October 24, 2017, Gridiron-PAC made a \$5,000 in-kind services prepayment to the NFL. The total funds retained by NFL as of March 31, 2018 was \$388.22. On April 25, 2018, Gridiron-PAC made an additional in-kind services prepayment to the NFL. In this reporting period, the prepayments are used to offset \$276.96. The total funds retained by NFL as of April 30, 2018 is \$5,111.26.
