
This is in response to your letter dated October 20, 2009 concerning the Amended July Quarterly Report (4/1/09-6/30/09) of Missouri New Hampshire Victory Fund (the Committee).

You have asked about the Committee's use of "best efforts" to obtain the donor names, mailing addresses, occupations and names of employers. The Committee's practice is to ask for the required information on all solicitations in a clear and conspicuous manner. If the information is not received with the contribution, a written follow-up request is sent within 30 days of receipt of the contribution. This request includes a pre-addressed and stamped return envelope.

When the Committee receives new information after a report is filed, it either amends the report to include the new information or files a memo Schedule A with its next regularly scheduled report.

We hope that this information adequately addresses your question. We have filed an amended report to provide election designations and additional employer and occupation information. If you need any further information, please do not hesitate to contact the Committee.
