This letter is to confirm that the Committee's Schedule B supporting Line 23 does provide the office sought including state and congressional district where applicable, for each contribution made. Those disbursements showing a district number are for representative/house races and that those without a district number are for disbursements to senate races.

Next, on September 14 an individual at the bank lockbox processing center mistakenly deposited a check in the amount of \$7,100.00 from the Columbia Management Company into the PAC's bank account.
