



Prior to this reorganization we consistently complied with all reporting and disclosure requirements on FEC FORM 3X under the name of NSWMA WASTE PAC. Subsequent to the reorganization, we have begun using the name EIA WASTE PAC. Thus, this is the source of the confusion. Unfortunately, we failed to notify the FEC in a more timely fashion of this change because, as you can imagine, the scope of our reorganization and a move to new facilities predictably resulted in some notifications and other details falling through the cracks.

This is a follow-up to our telephone conversation of September 21, 1994, in which we discussed a letter from the Federal Election Commission (FEC) regarding an apparent -- but understandable -- misunderstanding over whether EIA WASTE PAC is a duly organized and registered "political committee" pursuant to 2 U.S.C. § 432(9). As we discussed, the National Solid Wastes Management Association (NSWMA) recently underwent a total corporate reorganization, one result of which was to change our name to the Environmental Industry Associations (EIA).
