
Dear Mr. Schumacher:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-The beginning cash balance of this report does not equal the ending balance of your Amended 30 Day Post-Runoff Report. Please correct this discrepancy and amend any reports which may be affected by the correction. ✓ok

-Your report discloses a transfer of joint fundraising receipts. You must provide a Memorandum Schedule A disclosing your share of gross receipts. Contributions from original contributors whose total contributions to your committee have exceeded \$200 during the calendar year 1997 should be itemized on this schedule. The itemization should include the full name, mailing address and zip code of the person, along with the name of his/her employer, the date of the contribution, his/her occupation, the election designation and the aggregate year-to-date amount of contributions made by this person. If necessary, please provide a memo Schedule A containing the required information. (11 CFR §102.17(c)(8)(i)(B))

-Your report contains contributions received from a joint-fundraising committee. In order for the principal campaign committee to receive transfers from a joint-fundraiser, the candidate must file a written statement authorizing these activities. This designation may be made by letter or by



amending the Statement of Candidacy (FEC FORM 2) (11 CFR §101.1(b). The principal campaign committee must amend its Statement of Organization (FEC FORM 1) to show the affiliation of the joint-fundraising committee and the separate account used for the proceeds. All contributions transferred to the principal campaign committee must be permissible under the Act. Please refer to Section 102.17 of the FEC regulations for information on the proper reporting of joint-fundraising committees.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
