

Dear Mr. Fournier:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Your Statement of Organization (FEC FORM 1) fails to designate a bank or other depository for committee funds. Commission Regulations require that "each political committee shall designate one or more State banks, Federally chartered depository institutions (including a national bank), or depository institutions the depositor accounts of which are insured . . . as its campaign depository or depositories." Additionally, Commission Regulations require "each political committee (to) maintain at least one checking account or transaction account at one of its depositories." Please amend your Statement of Organization to disclose the committee's depository.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
