This report is filed as a quarterly report because the PAC filed an extraneous report in April covering Jan 2019 to Mar 2019. Additionally, earlier this year the Statement of Organization was amended to update the contact emails for the PAC. Not long after, the PAC endured a significant change in personnel; a change which included the individuals who were to be the email contacts for the PAC. Unfortunately, the Statement of Organization was not updated to provide a current email address for the committee. At the time of the turnovers, it was believed that all FEC disclosure obligations had been addressed. Consequently, when the PAC missed filing the July Semi-Annual Report, the notification from the FEC was not received. Once the issues came to the committee's attention, immediate action was taken to remedy to situation. In order to ensure that a reoccurrence of late filing is unlikely, the committee addressed the operating process gaps. The committee has engaged legal counsel to advise on its compliance process, amended its operating procedures, and setup operational redundancies. Further, the committee is taking exhaustive efforts to educate all key personnel and the Board of Directors about its compliance obligations.
