This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

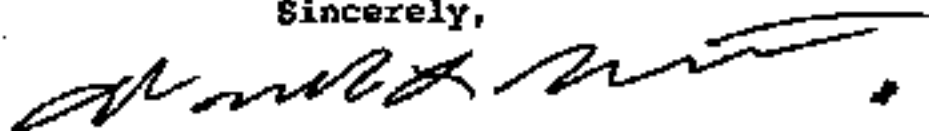

Please be advised that you should add the "Calendar Year-to-Date" total from your Amended 1995 October Quarterly report to the current "Total This Period" figure from Column A to derive the correct Line 11(c), Column B total. Please amend your report and any subsequent reports that may be affected by this correction.

-Please provide a Schedule B to support the entry reported on Line 28(c) of the Detailed Summary Page. Each refund made to a political committee must be itemized on Schedule B regardless of the amount refunded. 2 U.S.C. §434(b)

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. If you need assistance, please feel free to contact me on
